Objective and investment policy The IS Asset Allocation Fund is a UCITS mutual fund that invests in other UCITS-funds that invest in both domestic and foreign bonds and equities. The fund is not allowed to invest more than 30% in Non-UCITS funds and may only to invest up to 20% in one fund (both UCITS and AIF). In addition the fund may not invest in funds that have invested 10% or more in other funds. The fund is allowed to invest in derivatives, but no more than 10% of total assets. The fund is allowed to invest up to 50% of it's capital in other funds managed by IS Funds in accordance article 64 of the Act no. 116/2021. 


