
## Objective and investment policy


IS Private Fund A is a division in IS Private funds that invests in mutual funds, AIF for retail and institutional funds. The fund can also invest in individual securities. Investments through funds and directly can be in government quaranteed bonds such as government bonds, government bills and bonds issues by the Housing Financing fund. The fund can also invest directly or through funds in municipality bonds, other bonds and bills plus deposits.

IS Private Funds are Alternative Investment Funds for Retail Investors (AIF for retail) according to Act no. 45/2020. Marketing of the funds are therefore only allowed in Iceland.




